Sub: Intimation in terms of SEBI Circular No. SEBI/HO/MIRSD/DOS3/CIR/P/2018/139 dated November 6, 2018, pertaining to transfer of securities in physical mode ('the SEBI Circular').

The Securities and Exchange Board of India ("SEBI"), vide its Circular dated November 6, 2018, prescribed a standardized procedure for effecting transfer of securities in physical mode, including cases involving material mismatch of name or non-availability of transferor's signature.

Further, SEBI vide Circular No. **SEBI/HO/MIRSD/RTAMB/CIR/P/2020/166** dated September 7, 2020, fixed **March 31, 2021**, as the cutoff date for re-lodgment of transfer requests in physical mode and stipulated that such shares shall be issued only in demat mode. Subsequently, SEBI vide Circular No. **SEBI/HO/MIRSD/MIRSD-PoD/P/CIR/2025/97** dated July 02, 2025, extended the timelines for re-lodging documents for transfer of securities for shareholders who missed the March 31, 2021, deadline, and opened a **special window for re-lodgement from July 07, 2025, to January 06, 2026**.

Further, SEBI Circular No. **SEBI/HO/MIRSD/RTAMB/CIR/P/2020/236** dated December 2, 2020, prescribed the operational guidelines for transfer and dematerialization of re-lodged physical shares (collectively referred to as "SEBI Circulars").

Pursuant to the aforesaid SEBI Circulars, please find below the details of equity shares in respect of which transfer requests have been processed. The shares will be credited in demat mode in accordance with the prescribed procedure:
