DoCoMo had decided to exit Tata Teleservices in 2014 as its JV's performance was not up to the mark and had given Tata 90 days to find a buyer. With Tatafailing to find a buyer for DoCoMo's stake in the JV, DoCoMo had exercised its right to seek a buyback option.

The Tata group, however, could not repay the amount as the Reserve Bank India (RBI) felt it would violate Foreign Exchange Management Act (Fema) norms. The Japanese firm initiated arbitration proceedings, which ruled in favour of DoCoMo and fined the Tata Group\$1.17 billion.

The Financial Times said a person close to Tata said it was unlikely that Do-CoMo would be able to seize assets belonging to Tata Steel and Tata Motors as they were listed companies owned mostly by outside investors. DoCoMo declined to comment on the report.
